2 Expense Capture

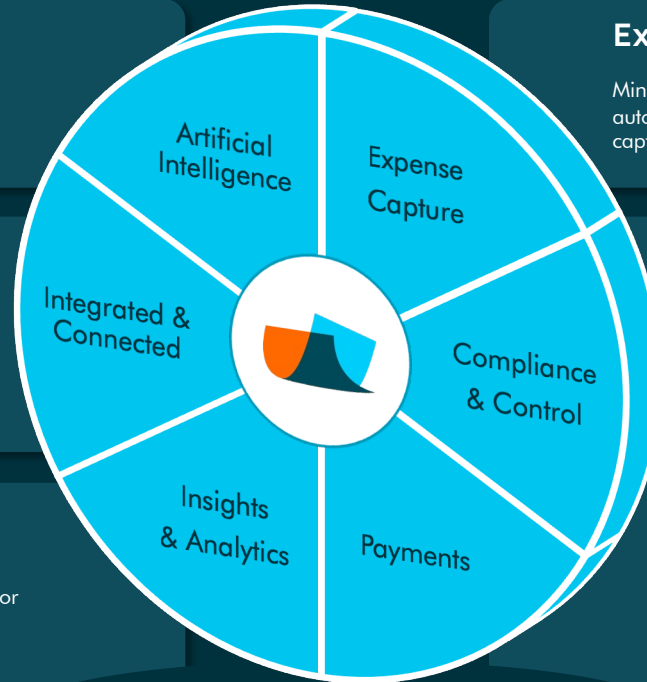
Minimal manual input using instant OCR and automatic data retrieval from various sources, capturing all relevant data automatically.

1. Vendor cards management

- An instance of vendor card management is the creation and management of cards that are dedicated to specific vendors.
- This can streamline the purchasing process, eliminate need for traditional purchase orders or reimbursements.
- This can also help with configuring spending limits and restrictions = greater control over expenditures.

2. Integration with Microsoft Dynamics Business Central – Financial Module

3. Apple Pay & Google Pay for Mobilexpense cards

- Employees can make payments quickly and securely using their mobile devices, saving time.



4. Automation in receipts categorisation
