


# A note regarding the roadmap


- This roadmap offers insights into ongoing innovation areas.

## 1. Capturing of CO2 drivers

Increasing requirement in Europe for companies to include the **disclosure of CO2 data** or to provide stakeholders with information on a company's environmental performance.

• We want to help with **identifying**, **recording**, **and reporting** the CO2 drivers. E.g. with employee commuting, business travel and accommodation services.

### 2. Travel request insights

We want to help organisations with more visibility for expected travel budget and expenses incurred. For instance, users can link travel requests to actual expenses. Users get to plan ahead by adding flights, car rental and accommodation.

#### 3. SpendController performance improvements

Enhance the capabilities of our control automation tool to increase speed and ease of decision-making for our controllers.

• E.g: lower flagging sensitivity of spelling errors or multilanguage results.

## 4. Support EU e-Invoicing regulation

Support customers in complying with new EU e-Invoicing regulations by automating the processing and controlling of electronic invoices.

• Improve ingestion and control of expenses and invoices following e-Invoicing regulations for better integration with ERP systems.





## 5. Simplify processing of travel expenses

To ensure accurate calculation of a total trip cost for further reconciliation and settlement process.

• For instance: **Ingestion of BCD Travel's Travel Expenses to** improve the user experience by **automating** the process of adding of their travel expenses and receipt into MXP.

#### 6. Improvement in Daily Allowances user experience

Modernise and simplify the user experience of our Daily Allowance module for all types of journeys.

- Fill and edit the form with ease, with guided steps throughout the way.
- Greater transparency of calculation information to empower end-users.
